It has been the headquarters of the district since 1883 AD. The region Mahabubnagar was once known as cholawadi or the land of the cholas.it is said that "KOHINOOR" diamond came from Mahabubnagar district. 700 years old Pillalamarri the great banyan Tree, Asia's Second, spreads in ten acres of land is in Mahabubnagar town. 500 years old Manyamkonda Venkateshwara Swamy Temple at Manyamkonda hill is an ancient shrine dedicated to lord Venkateshwara about 16 kilometers from district headquarters. Mahabubnagar Town is located at a distance of 96 km from Hyderabad, Telangana state capital. It is well connected by road, rail and air facilities. Shamshabad International Airport is just 75 km to Mahabubnagar town.
